The Upper Canada Medal, originally created by the Loyal and Patriotic Society of Upper Canada, recognized the service of volunteer soldiers in the War of 1812.

Recognizing an even greater need, the Society decided in 1829 to reduce the medals to gold bullion to pay for building the original Toronto General Hospital.
